# **ACR Congressional Update**

Medicare FFS Professional Component Multiple Procedure Payment Reduction (MPPR): Despite our members' response to the ACR's call to action asking our US Senators and Congressmen to support S. 2247/H.R. 3269 (Diagnostic Imaging Services Access Protection Acts), these were not incorporated in The American Taxpayer Relief Act of 2012 at the end of the 112th Congress. This was due in part to the chaos that surrounded the fiscal cliff situation and our PC MPPR legislation didn't generate any "savings" to the Medicare program. Now in the 113th Congress, Representatives Pete Wilson (R-TX), Peter Roskam (R-IL), John Barrow (D-GA) and Betty McCollum (D-MN) along with 38 House cosponsors, have reintroduced the Diagnostic Imaging Services Access Protection Act as H.R. 846. This would stop a 25 percent Multiple Procedure Payment Reduction to Medicare reimbursement for interpretation of advanced diagnostic imaging scans performed on the same patient, in the same session. In the Senate, the ACR anticipates that Senators Ben Cardin (D-MD) and David Vitter (R-LA) will again introduce a similar bill in the coming weeks.

SGR: The House Ways and Means Committee and Energy and Commerce Committees have released a broad proposal for repealing the flawed formula (press release 2/7/2013) to include 3 phases: PHASE 1: Repeal the SGR and provide a period of predictable, statutorily-defined physician payment rates. PHASE 2: Reform Medicare's fee for service (FFS) physician payment system to reward physicians who provide high quality care and PHASE 3: Build upon the improvements made in Phase 2 by also rewarding physicians who deliver efficient care.

Congressional Budget Office (CBO) released its annual review of the federal budget and economy entitled The Budget and Economic Outlook: Fiscal Years 2013 to 2023 (page 31): This found that the overall cost of canceling the SGR formula is now approximately \$138 billion over 10 years. This is a reduction of greater than \$100 billion compared to the previous 10 year cost estimate published August 2012. This reduction is in part because of lower spending on physicians' services over the past 3 years in relation to established spending targets.

As in years past, the program will cover the spectrum of head and neck anatomy and pathology. This year's invited faculty and moderators comprise a group of household names, familiar faces, and some fresh young talent!

During the five-day course, you will hear outstanding lectures covering anatomy and pathology of the neck, skull base & temporal bones, sinonasal cavities and orbits. The meeting will kick off Wednesday morning with the popular "Early Bird Temporal Bone" session. Attendees are encouraged to bring an interesting temporal bone case to share with the experts and your colleagues.

Thanks to the contributions of our membership to the Core Curriculum Fund (CCF), a Hanafee Research Grant was awarded at the 2012 Annual Meeting and Dr. Page Wang will present on the progress of her work on Wednesday. Hopefully, you will be inspired to make a contribution to the CCF while you are at the meeting!

Our Gold Medal Luncheon will be held on Thursday and I am very happy that we will be honoring a most deserving recipient, Dr. Patricia A. Hudgins. Most of Saturday will focus on a variety of topics related to head and neck cancer. To help everyone meet the recertification requirements of the ABR, 3 SAM sessions will be offered. The topics covered in the SAM sessions are different from those covered at the 2012 Annual Meeting and will focus on the

temporal bone, the oral and maxillofacial region, and the sinonasal cavities. Special "How I Do It" and "Case-Based Approach" sessions will be sprinkled throughout the program. No ASHNR meeting would be complete without a game show and this year it will be the "ASHNR College Bowl"! We will also have a charity event at the meeting, "Hugs for Fragile X". The proceeds will benefit FRAXA, the Fragile X Syndrome Research Foundation. Fragile X Syndrome is the most common genetic case of autism. Details about the benefit will be highlighted on the opening day of the meeting, but for now, let me just say, bring your \$1 bills!
