About The ASHNR

The American Society of Head and Neck Radiology (ASHNR) is a professional, non-profit, medical society comprised of over 900 physicians and other health care providers with an interest in imaging and pathology of the head and neck. Founded in 1976, the ASHNR has a strong academic mission, providing intensive educational programming and promoting research in the field of head and neck imaging.

About The ASHNR Annual Meeting

The ASHNR Annual Meeting is the premier national event for head and neck imaging and will be held in Savannah, Georgia from September 26-30, 2018. There will be over 100 invited lecturers and moderators who are leaders in the field as well as in their practice settings. The 2017 meeting in Las Vegas, Nevada drew over 600 registrants.

The wide range of radiologists in attendance includes specialists in neuroradiology, head & neck imaging, emergency radiology and pediatric radiology, as well as a substantial number of general radiologists. The 52nd Annual Meeting will include sessions devoted to advances in head and neck cancer imaging and improving CT and MRI imaging protocols, as well as a series of lectures designated as “core curriculum” that will cover more basic topics, including difficult head and neck anatomy. Four SAM sessions will help registrants meet the recertification requirements of the ABR, a proven registration “draw”. Scheduled refreshment breaks, as well as Wednesday evening’s Opening Reception, will be held in the technical exhibits room allowing multiple opportunities for registrants to engage with exhibitors.

Savannah is easily accessible by direct flights from numerous cities including New York, Chicago, Atlanta, Dallas/Fort Worth and Houston. Known as “The Jewel of the South”, the city is graced by 22 historic squares, landmark homes, numerous museums and exceptional dining. The Westin Savannah Harbor Golf Resort and Spa has a unique location on an island in the Savannah River 5 minutes by free ferry and 10 minutes by car from the downtown historic district. An 18-hole Sam Snead-designed golf course was home to the PGA TOUR’s Legends of Golf Champions Tour event from 2003-2013, and will be home to Friday afternoon’s 9-hole tournament, open to registrants and exhibitors. We hope you will join us at this outstanding medical societal event.
